Specimen: Biopsy from an ulcero-proliferative lesion on right side of gingivobuccal region.(SKB – 136/ 2026)

Clinical details: History not received.

Gross findings: Specimen consists of multiple irregular grayish white tissue bits meas. 0.8x0.5 cm. in toto.

Microscopic findings: H/E stained section reveals malignant tumour composed of infiltrating nests of malignant squamous epithelial cells.

The cells are polygonal with altered nuclear to cytoplasmic ratio and vesicular nuclei with abnormal mitotic figures.

The stroma also shows moderate mixed cellular inflammatory infiltrate.

Lymphatic/vascular emboli are not seen in the tissue sent.

Impression: S/o Infiltrating moderately-differentiated, keratinizing squamous cell carcinoma.

REMARK :IHC studies are essential for definitive diagnosis.
