

Notice & Fee Structure for July 2026 (Existing Batches)

The Institute will reopen on 20 July, 2026 (Monday) for all UG/PG existing batches.

As per academic calendar for odd Semester of A.Y. 2026-2027 fee payment schedule for all existing batches like B.Tech-2023, B.Tech-2024, B.Tech-2025, M.Tech-2025, MBA.-2025 including M.Tech.(BR)/MBA(WP) and PhD (Regular)/PhD (WP) program are as follows-

Online Fee payment will be started from – 15-06-2026 (Monday) to 20-07-2026 (Monday)

Online Fee payment with late fee schedule is given below –

₹1000/-	:	21-07-2026 (Tuesday) to 22-07-2026 (Wednesday)
₹5000/-	:	23-07-2026 (Thursday) to 24-07-2026 (Friday)

2- If a student fails to deposit fees by 24-07-2026 (for B.Tech/M.Tech./MBA./PhD), his/her name will stand struck off from the rolls of the Institute and he/she will not be allowed to attend classes/ avail facilities of the Institute.

3- In fee structure only double occupancy fees notified for UG students. They will must pay the single occupancy additional charges of ₹13,580/- separately in account office on allotment of single occupancy room.

4- DASA student's US Dollar tuition fee will be paid in only US\$ (not to be paid in INR) directly to the Institute fee account via wire transfer. Institute bank details for DASA Non SAARC & DASA SAARC students for Tuition fee payment in Bank Account as detailed below :
